MINUTES WOOLWICH TOWNSHIP COMMITTEE SEPTEMBER 7, 2021

Mayor Marino called the meeting to order at 6:03 p.m.

Mayor Marino made the following statement:

The September 7, 2021 regular meeting of the Woolwich Township Committee is being called to order. Adequate notice of this meeting has been given in accordance with the Open Public Meetings Act.

Those present saluted the American Flag.

Motion was made by Deputy Mayor Matthias and seconded by Committeeman Callahan to approve resolution R-2021-154 Resolution of the Township of Woolwich Appointing Bryan Hill, Luke Trifiletti and Scott Thomas to the Position of 9th Class Patrol Officers and Jerry Parker to the Position of Academy Recruit within the Woolwich Township Police Department. Roll call: Callahan: YES, Frederick: YES, Nocentino: YES, Matthias: YES, Marino: YES Motion carried

Mayor Marino administered the Oath of Office to the four new patrolmen.

Deputy Chief Joe Morgan thanked the Committee for their support of the Department, and he welcomed the new officers.

Gloucester County Commissioner Jim Lavender and Mayor Marino both issued Proclamations to resident Joseph Musumeci and proclaimed September to be "Prostate Cancer Awareness" month.

Mr. Musumeci, who is very active in prostate cancer awareness, advised all men over 40 to have their PSA checked. He also provided prostate cancer statistics, and the negative effect of COVID on diagnosis and treatment.

Mayor Marino called a five minute break at 6:19 p.m.

The meeting resumed at 6:25 p.m. at which time Deputy Mayor Matthias moved to open the floor to public comment on agenda items only. Committeeman Frederick seconded. All were in favor.

Hearing no comment, the public portion was closed upon a motion by Deputy Mayor Matthias, seconded by Committeeman Nocentino and unanimously approved

Committeeman Frederick asked Township professional Jeff Winitsky of Parker McCay to clarify the terms of the PILOT Agreement, noting that there is no escalator in years 1-13 in the PILOT.

Mr. Witinsky noted that consideration be given to the developers total of three PILOT's as an aggregate, that represents two to three times the tax the Township would see otherwise. He added that the cost of developer improvements to the Rt. 322/Locke Avenue intersection should also be considered.

Committeeman Frederick stated that \$1.25 per sq. ft. appears to be lower than other approved PILOTS.

Committeeman Callahan asked how this will set up the Township for future PILOT negotiations. Mr. Winitsky responded that all PILOTS are looked at differently.

Deputy Mayor Matthias moved to approve a consent agenda for resolutions R-2021-155 through and including R-2021-157. Committeeman Frederick seconded. All were in favor.

Deputy Mayor Matthias moved to adopt resolutions R-2021-155 through and including R-2021-157. Committeeman Frederick seconded.

R-2021-155 Resolution of the Township of Woolwich Supporting a Regional Municipal Court Study in Gloucester County

R-2021-156 Resolution Authorizing Release and Closure of Escrow Account

R-2021-157 Resolution Authorizing the Tax Collector to Transfer/Refund Overpayment of Taxes

Committeeman Frederick asked resolution R-2021-155 is coming from the Administrative Office of the Courts. Mayor Marino replied that it is.

Committeeman Frederick then asked if other courts are taking the same initiative. Mayor Marino replied that this will be the first in the State, adding that Gloucester County leads in shared services.

The Mayor added that the plan is to create four or five regions, one of which will be Woolwich.

Committeeman Frederick asked if there is a proposed time line. The Mayor replied that no time line has been given.

There was no old business.

Deputy Mayor Matthias moved to open the floor to public comment. Committeeman Nocentino seconded. All were in favor.

Ann Dorsett, 169 Russell Mill Road, congratulated the township for surviving the September 1st storm without major damage.

Mrs. Dorsett also asked if there are any updates to TDR. The Mayor advised that the township will conference with TDR Counsel in the morning.

With no further comment, Deputy Mayor Matthias moved to close the public portion. Committeeman Frederick seconded. All were in favor.

Motion was made by Deputy Mayor Matthias and seconded by Committeeman Callahan to approve resolution **R-2021-158 Resolution for Closed Session** for the purpose of discussing Litigation: GRC Complaint; Potential Litigation: Windsor Drive Zoning; Contractual: Weatherby Apartment PILOT and Porches Mill Dam Agreement. All were in favor.

The Committee entered closed session at 6:46 p.m.

The regular meeting resumed at 7:51 p.m. upon a motion by Deputy Mayor Matthias seconded by Committeeman Nocentino and unanimously passed.

Under new business, Deputy Mayor Matthias moved to authorize the Solicitor to offer up to \$2,500 to settle a GRC complaint regarding OPRA. Committeeman Callahan seconded. All were in favor.

Also under new business, Committeeman Frederick advised that the Township may need to consider hiring for a position to oversee development of Rt. 322, since so many projects are coming before the Township.

Discussion commenced among the Committee

The Committee asked the Administrator/Clerk to review, provide an analysis of need and compile what specialties should be required over the next few months.

Motion was made by Deputy Mayor Matthias, and seconded by Committeeman Nocentino to approve the bill list and purchase orders.
