MINUTES WOOLWICH TOWNSHIP COMMITTEE DECEMBER 20, 2021

The meeting was called to order by Mayor Vernon Marino at 6:03 p.m.

Mayor Marino made the following statement:

The Township Engineer advised that they have been contacted by NJDEP noting that DEP requires the Township to withdrawal its applications for the Locke Avenue Park Expansion permitting and resubmit as an additional stream analysis is required and also flood elevation analysis must be submitted. He noted that this will delay permit approvals further.

Committeeman Frederick asked for an adjusted project timeline and was told that the application can be submitted in mid-January, with a 90 day review period on the part of NJDEP.

The Committee authorized resubmission of the permit applications.

Precision Land: Monthly Sewer Project Update Andrew Shawl provided a status update of sewer installation and discussed attempts to obtain easements from developer Wolfson.

Mayor Marino suggested that the Solicitor send notice to the developer advising him that the cost of mobilization and demobilization will be on him.

Mr. Shawl also advised that Pioneer Pipe has begun water pipe installation on the behalf of Aqua.

Mayor Marino waived Committee Liaison Reports.

There was no old business.

Deputy Mayor Matthias moved to open the meeting to public comment. Committeeman Frederick seconded. All were in favor.

Ann Dorsett, 169 Russell Mill Road thanked the Committee for hosting the volunteer thank you dinner.

Jordan Schlump, 10 Wilshire Blvd. said it is good to hear the water/sewer updates and asked if there is an estimated time for service. Mayor Marino advised that the estimate is for mid-2022.

Harold Twiss, 246 Oak Grove Road wished to introduce himself, noting that he sent a letter recently to Committee asking for rezoning of his property.

Mayor Marino replied that he does not see any issues with the request, but that any action would have to be taken in 2022.

Motion was made by Deputy Mayor Matthias and seconded by Committeeman Frederick to close the public portion.

Deputy Mayor Matthias prompted discussion regarding park tournament fees, suggesting that fees be increased. The Committee discussed to proposed amended fees.

Committee asked the CFO to develop a print out of all tournament costs in 2021.

Deputy Mayor Matthias moved to approve the update to the Field Use Schedule.

The Administrator/Clerk advised that the fees are codified and amendments will have to be made via Ordinance after the first of the new year.

The Deputy Mayor withdrew her motion.

Mayor Marino thanks Deputy Mayor Matthias and Committeeman Frederick for their update.

Motion was made by Mayor Marino and seconded by Deputy Mayor Matthias to approve resolution **R-2021-230 Resolution for Closed Session.** All were in favor.

The Committee entered closed session at 6:38 p.m. for the purpose of discussing the following matters:Personnel:Transition of Finance Office; Police MatterLitigation Update:Chestnut Ridge
