Public Hearing – Amendment to the Round 3 Fair Share Housing Plan

Mike Jedziniak, The Township's attorney for this introduces himself and gives a quick overview of the affordable housing plan was started and where the Township is with the rounds of plans that were adopted and where we are now.

Then the JLUB Planner, J. Petrongolo reviews the obligations that are required by the plan. He discusses the types of compensation that are available, such as rehabilitation housing, prior round obligations and present need. This adoption will be a part of the Twp. Master Plan.

Mr. Petrongolo reviews the credits and where the obligations are generated from.

J. Juliano asks about any changes to the Master Plan, do these requirements change. Mr. Petrongolo says the numbers stay the same. Mayor Frederick asks about the timeline to do this. Mr. Jedziniak says that you have to create a reasonable opportunity for a builder to complete the project. FSH has vetted these spots and agreed that they are well suited for building. If the total number isn't met by 2025 when this gets discussed again, the totals just move to the next round.
