- G. Wheeler of 123 Weston Dr, Monroeville, Owner of property on Oldman's Creek Rd. expresses concerns
- K. Menicklla of 119 Fox Chase Ct, farm land and quality of life comments
- A. Dorssett of 169 Russel Mill Rd, in favor of elimination of TDR.
- B. Hannigan of 25 Natalie Dr mentions that the majority of the residents prefer the open land vs the small amount of farmers this affects.

Fencing around the facility and landscaping are discussed as is access to this unmanned site.
