Tax Collector: \$237,623.04 remitted

Woolwich Fire Company: Monthly Report

Chief Valichka noted that 67 calls for service were logged, 36 of which were in Woolwich Township. There have been 400 calls to date. The department has requested a voluntary PEOSHA audit in August. Department training continues. Two new members will be attending the fire academy. Fund raising is going well. On August 8<sup>th</sup>, the Department will celebrate its 125<sup>th</sup> anniversary.

Deputy Mayor Callahan inquired as to a comparison in the number of calls. The Chief replied that calls are on track since 2022 saw a total of close to 800 calls. The department will continue discussions regarding calls to the NJ Turnpike.

Police: Monthly Report 36 cadets signed up to attend the youth academy camp which will be held at the Harker School. Sgt. Beckett has been named Officer of the Quarter.

Township Engineer: Monthly Report

The NJDOT Swedesboro Avenue road project is anticipated to begin on August 7<sup>th</sup>. Survey of ROW was conducted for the High Hill Path project. ROW Access Permit was signed regarding the Viereck Road project. Working with departments as to MS4 compliance. Inlet mapping inspections have begun in this regard. Pickle Ball Court survey is complete, and design is ongoing. Provided an estimate of Oak View Terrace reconstruction. Suggested that work on the Center Square walking path be done in conjunction with the High Hill Path Phase 3 project for fiscal reasoning. Discussed culvert repairs, some of which are under county jurisdiction. Briefly discussed Warrington Mill Dam.

Mayor Frederick advised that a call was held with NJDEP as to permitting of the park expansion project. He noted that the preliminarily, it seems that the results of the archeologic study will not call for a phase 2. He is hopeful that all permit applications have been received by NJDEP and they have begun their 90 days review.

The Mayor further noted that signatures have been received from all parties on the Oliphant Mill Dam Agreement and that permitting applications have been submitted to NJDEP. He further advised that follow up with legal counsel and engineering is underway as to final improvements in Lexington Mews.

The Administrator/Clerk presented her report as self-explanatory. There were no questions from Committee.

Municipal Services: Monthly Report

The following Committee liaison reports were given:

#### Committeeman Marino:

Solid Waste/Recycling; 55 cardboard, 142 metal and 342 bulk collections in June. Continuing to be assessed fines for plastic contamination in recycling. JLUB; Next meeting, August 3<sup>rd</sup>. Special Projects; Speed humps on Frederick Blvd. have been installed, striping completed and signage on order. Further discussed including Garwin Road culvert in conjunction with NJDOT Garwin Road project.

#### Committeewoman Minhas:

Municipal Alliance; Recreation. Committeewoman Minhas had no report on either subject.

#### Committeeman Nocentino:

Municipal Services; 34 zoning permits issued in June. Fire was set in trash container on July 4<sup>th</sup>. Minor damage to concession stand. Road side cutting continues. Env. Commission; Working towards raised bed community garden at Auction Park. Social Media/IT; NO report.

#### Deputy Mayor Callahan:

Educational Partners (SWSD/KRSD); Plan to meet with Dr. Lavender to continue review of flashing signal traffic signage. Resident Communications; No report. Park Utilization; No report.

#### Mayor Frederick:

Administration; Reviewing budget financials and preparation of PILOT assessment. More to come. Public Safety; Previously provided by Chief Morgan.

#### There was no old business.

Under new business, Mayor Frederick advised of efforts to improve resident communications in order to find ways to provide better information in a timelier manner. Advised that a meeting was held with a local resident, owner of "Step Ahead Web" and have received a quote for redesign of website and maintenance plan. More to come.

Deputy Mayor Callahan noted that competitive quotes should be received.

Committeeman Marino noted the most recent vehicle crash at the Oldmans Creek/Kings Hwy. intersection. The County is aware as this is a county intersection. County has agreed to perform a traffic study. Mayor Frederick added that the Township has requested that the County also conduct a study at Kings Hwy//Paulsboro Road.

The Mayor also noted that he is hoping to receive the truck route study from R&V soon, and that we are trying to schedule a mtg. With NJDOT regarding Rt. 322 development.

Mayor Frederick and Committeeman Marino advised of the reopening of Locke Avenue, completing ½ of the intersection improvement with opening tentative for November. Mayor Frederick advised that

the project is one month ahead of schedule.

Motion was made by Committeewoman Minhas and seconded by Committeeman Nocentino to open the meeting to public comment. All were in favor.

Hearing no comments, the public portion closed upon a motion by Committeeman Marino, seconded by Committeewoman Minhas and unanimously passed.

Deputy Mayor Callahan moved to approve resolution **R-2023-168 Resolution for Executive Session.** Committeeman Marino seconded. All were in favor.
