MINUTES WOOLWICH TOWNSHIP COMMITTEE OCTOBER 2, 2023

The meeting was called to order at 6:32 by Mayor Craig Frederick.

Motion to adopt: Minhas Second: Callahan

Committeewoman Matthias asked if a permit application form has been developed. Ms. DiBella advised that form has been created. Discussion then ensued regarding whether or not applicants should submit a site plan of the event space, and Committeewoman Matthias also stated that an event end date is crucial and should be added to the Ordinance. After discussion, modifications to the permit application form will be made, but the Ordinance wording will remain.

R-2023-211 Resolution Authorizing the Tax Collector to Transfer, Refund/Cancel Overpayment of Taxes
